BIS-SAĦĦA tas-setgħat mogħtija bl-artikolu 25 ta' l-Att dwar is-Saħħa Pubblika, il-Ministru tas-Saħħa, l-Anzjani u Kura fil-Komunità għamel dawn ir-regolamenti li ġejjin:-

**1.** It-titolu ta' dawn ir-regolamenti hu **Regolamenti ta' l-2007** Titolu.  
dwar Kumitat li jagħti Pariri fuq il-Politika ta' Immunizzazzjoni.

**2.** Għandu jitwaqqaf mill-Ministru responsabbli għas-saħħa Twaqqif ta' Kumitat.  
Kumitat li jagħti Pariri fuq il-Politika ta' Immunizzazzjoni, hawn iżjed 'il quddiem imsejjah "il-Kumitat".

**3.** Ikun id-dmir tal-Kumitat li:

Dmirijiet tal-Kumitat.

(a) iġib 'il quddiem konozzenza tal-programm ta' immunizzazzjoni, u sostenn għalih, fost il-professjonisti u l-pubbliku ġenerali;

(b) iżomm ruħu aġġornat dwar l-aħħar riċerka fl-iżvilupp tal-vaċċini;

(ċ) jagħti parir lis-Suprintendent tas-Saħħa Pubblika dwar il-prioritajiet li għandhom japplikaw fil-programm ta' vaċċinazzjoni fi żmien qasir, medju u fit-tul;

(d) jizviluppa rakkomandazzjonijiet dwar l-amministrazzjoni ta' vaċċini li tingħata b'rutina;

(e) johroġ linji direttivi dwar dosaġġ, perjodiċità u kontra-indikazzjonijiet li japplikaw għal vaċċini individwali;

(f) jagħti pariri skond ma jista' jiġi mitlub jagħmel mis-Suprintendent tas-Saħħa Pubblika.

Ghamla tal-Kumitat.

- 4.** (1) Il-Kumitat ghandu jkun magħmul kif ġej:
- (a) president li jiġi nominat mis-Suprintendent tas-Sahha Pubblika;
  - (b) speċjalista fil-Medicina tas-Sahha Pubblika;
  - (c) speċjalista fil-Pedjatrija;
  - (d) speċjalista fil-Viroloġija;
  - (e) speċjalista fil-Mikrobioloġija/Batterjoloġija;
  - (f) speċjalista fil-Mard Infettiv;
  - (g) spiżjar.

(2) Ghandu jkun hemm Segretarju tal-Kumitat li jinhatar mis-Suprintendent tas-Sahha Pubblika.

**PUBLIC HEALTH ACT  
(CAP. 465)**

**Advisory Committee on Immunisation Policy Regulations, 2007**

IN exercise of the powers conferred by article 25 of the Public Health Act, the Minister of Health, the Elderly and Community Care has made the following regulations:-

**1.** The title of these regulations is the Advisory Committee on Immunisation Policy Regulations, 2007. Title.

**2.** There shall be established by the Minister responsible for health an Advisory Committee on Immunisation Policy, hereinafter referred to as “the Committee”. Establishment of Committee.

**3.** It shall be the duty of the Committee to: Duties of the Committee.

(a) promote the understanding of, and support for, the immunisation programme among professionals and the public at large;

(b) keep abreast of the latest research in vaccine development;

(c) advise the Superintendent of Public Health with respect to vaccination programme priorities in the short, medium and long term;

(d) develop written recommendations for the routine administration of vaccines;

(e) issue guidelines regarding dosages, periodicity and contraindications applicable to individual vaccines;

(f) tender advice as may be requested by the Superintendent of Public Health.

**4.** (1) The Committee shall be composed as follows: Composition of the Committee.

(a) a chairperson to be nominated by the Superintendent of Public Health;

(b) a specialist in Public Health Medicine;

- (c) a specialist in Paediatrics;
- (d) a specialist in Virology;
- (e) a specialist in Microbiology/Bacteriology;
- (f) a specialist in Infectious Disease;
- (g) a pharmacist.

(2) There shall be a Secretary to the Committee who shall be appointed by the Superintendent of Public Health.

**5.** The Committee shall regulate its own procedure.
